INCREMENTS AND HOTEL OCCUPANCY TAX INCREMENTS WILL BE DETERMINED AND USED TO FUND A PORTION OF THE COSTS OF ECONOMIC DEVELOPMENT PROJECTS, IN ACCORDANCE WITH AND AS AUTHORIZED BY PART II OF CHAPTER 27 TITLE 33 OF THE LOUISIANA REVISED STATUTES OF 1950, AS AMENDED; DESIGNATING THE GOVERNING AUTHORITY OF THE DISTRICT; REQUIRING THE BASELINE SALES TAX AND HOTEL OCCUPANCY TAX COLLECTION RATE IN THE DISTRICT TO BE CERTIFIED; DEFINING THE BOUNDARIES THEREOF; AND PROVING FOR OTHER MATTERS IN CONNECTION THEREWITH.
